Release and Waiver of Liability and Indemnity Agreement

WARNING: Motorcycle riding can be dangerous. Each participant has the responsibility to assess the safety aspects of facilities and conditions and **MUST** assume the risk involved with motorcycle riding.

** I/WE UNDERSTAND THAT THE PARTICIPANT PROVIDES THEIR OWN MEDICAL INSURANCE AND THAT THE OSHAWA COMPETITION MOTORCYCLE CLUB/ OFFICERS/DIRECTORS/CHAIRPERSONS/ORGANIZERS/LANDOWNERS DOES NOT PROVIDE PARTICIPANTS WITH MEDICAL INSURANCES.**

IN CONSIDERATION of being permitted to enter for any purposes and RESTRICTED AREA (herein defined as including but not limited to the racing surfaces, pit areas, parking area, burnout area, approach area, shut down area and all walkways, concessions and other areas appurtenant to any area where any activity related to the event shall take place), or being permitted to compete, officiate, observe, work for, or for any purpose participate in any way in the event, EACH OF THE UNDERSIGNED, for him/her self, his/her personal representatives, heirs and next of kin, acknowledges, agrees and represents that he/she has, or will immediately upon entering any of such restricted areal and will continuously thereafter, inspect such restricted areas and all portions thereof which he/she enters and with which he/she comes in contact and he/she does further warrant that his/her entry upon such restricted area or areas and his/her participation, if any, in the event, constitutes an acknowledgement that he/she has inspected such restricted areas and that he/she further agrees and warrants that if, at any time, he/ she is in or about restricted areas and he/she feels anything to be unsafe, he/she will immediately advise the officials of such and will leave the restricted areas:

I/WE HEARBY RELEASE, WAIVE, DISCHARGE AND COVENANT NOT TO SUE the Oshawa Competition Motorcycle Club it's directors, officers or chairpersons, the promoters(s), participants, racing association, sanctioning organizations or any subdivision thereof, track operator, track owner, land owner, officials, car owners, motorsport owners, drivers, racers, pit crews any persons in any restricted area, sponsors advertisers, owners, lessees of premises used to conduct the event and each of them, their officers, agents, family and employees, all for the purpose herein referred to as "Releasees", from all liability to the undersigned, my/our personal representatives, assigns, executors, heirs and next of kin for any and all claims, demands, losses or damages on account of any injury, including but not limited to the death of the participant or damage to property, caused to alleged to be caused in whole or in part by the negligence of the "Releasees" or otherwise while the undersigned is in or upon the restricted area and/or, competing, officiating in, observing, working for, or for any purpose participating in the event.

1. The parents(s) and/or legal guardian will instruct the minor participant that prior to participating in the above motorsport activity or event, he or she should inspect the facilities and equipment to be used and if he or she believes is unsafe, the participant should immediately advise the officials of such condition and refuse to participate.

2. I/We fully understand and acknowledge that:
 - a) There are risks and dangers associated with participation in motorsport events and activities which could result in bodily injury partial and/or total disability, paralysis and death.
 - b) The social and economic losses and/or damages, which could result from those risks and dangers described above could be severe.
 - c) These risks and dangers may be caused by the action, inaction or negligence of the participant or the action, inaction or negligence of the others, including but not limited to the "Releasees" named above.
 - d) There may be other risks not known to us or not reasonably foreseeable at this time.
3. I/We accept and assume such risks and responsibilities for the losses and/or damages following such injury, disability, paralysis or death, however caused and whether caused in whole or in part by the negligence of the "Releasees" named above.
4. On behalf of the participant and individually the undersigned parent(s) and/or legal guardian(s) for the minor participant executes this Waiver and Release. If, despite this release, the participant makes a claim against any of the "Releasees", the parent(s) and/or legal guardians(s) will reimburse the "Releasees" and their insuring company for any money which they have paid to the participant, or on his behalf and hold them harmless.
5. I/WE HEREBY AGREE TO INDEMNIFY AND SAVE AND HOLD HARMLESS the "Releasees" and each of them from any loss, liability, damage, or cost they may incur due to the presence of the undersigned in or upon the restricted area or in any way competing, officiating, observing, or working for, or for any purposes participating in the event and whether caused by the negligence of the "Releasees" or otherwise.
6. I/WE HEREBY ASSUME FULL RESPONSIBILITY FOR AND RISK OF BODILY INJURY, DEATH OR PROPERTY DAMAGE due to the negligence of the "RELEASEES" or otherwise while in or upon the restricted area and/or while competing, officiating, observing, or working for, of for any purpose participating in the event.

EACH OF THE UNDERSIGNED, expressly acknowledges and agrees that the activities of the event are very dangerous and involve the risk of serious injury and/or death and/or properly damage. EACH OF THE UNDERSIGNED further expressly agrees that the foregoing release, waiver and indemnity agreement is intended to be as broad and inclusive as is permitted by the law of the Province in which the event is conducted and that if any portion thereof is held invalid, it is agreed that the balance shall, notwithstanding continue in full legal force and effect.

I/WE HAVE READ THE ABOVE WAIVER AND RELEASE, UNDERSTAND THAT I/ WE GIVE UP SUBSTANTIAL RIGHTS BY SIGNING IT AND SIGN IT VOLUNTARILY WITHOUT INDUCEMENTS.
